Introduction

References to the “Entrant” are references to the author of the entry (the “Entry”) submitted to the prize draw detailed below.

References to “the Promoter” are references to The Orion Publishing Group Limited, Carmelite House, 50 Victoria Embankment, London, EC4Y 0DZ.

These Terms and Conditions apply to the “**Coming Home to Island House – Win a Weekend in Suffolk Competition**” (the “Prize Draw”). By entering this Prize Draw, you agree to accept and be bound by these Terms and Conditions. All entry instructions form part of the Terms and Conditions of this Prize Draw.

The Prize
